The Pillar of Daylight

The Board of Governance are excited to unveil the reo Māori name for The Broken Movement Trust - Te Pou Awatea.

With the aim of creating hononga, connection and belonging, and honouring our Treaty partnerships under Te Tiriti o Waitangi deliverying to over seventy-five per cent of our whānau base identifying as Māori, Te Pou Awatea encourages a sense of identity for the organisation that ensures our mahi is firstly kaupapa Māori values focussed, and driven in a waka that is whānau-centric.



EXPLAINATION:

Te Pou Awatea – The Pillar of Daylight leans on the purpose of The Broken Movement Trust, its vision and purpose to lead people away from the Darkness and into the Light.

'Pou' means pillar – a post strongly embedded and fixed in the ground often used as a foundation, support beam or signifies location and landmark creating clarity of location when someone is lost.

In reference to The Broken Movement Trust, the 'Pou' signifies a strong support beam and clarity of landmark in someone's life when people feel lost and withering from effects of Mental Health issues.

'Awatea' means daylight signifying that when there is darkness, there will always be day and with daylight creates vision, perspective, and pushes away the darkness of despair.

In reference to The Broken Movement Trust, 'Awatea' encourages that the work we do and the services we offer will provide Daylight through the darkness where Mental anguish has provided lack of clarity, sight, or vision.



As we reflect on the closing of 2023 and our journey into 2024, it's clear that The Broken Movement Trust has experienced a period of incredible growth and success, despite ongoing challenges. This has been a transformative time for our organisation, filled with both significant milestones and hurdles to overcome.

A highlight for us was our feature on TVNZ's Seven Sharp, which brought greater visibility to the important mahi we are doing. This exposure has helped us connect with even more people in need and strengthened our reputation within the community.



Over the past year, we've expanded our networks and formed important relationships with other organisations. I was honoured to be a keynote speaker at He Waka Tapu's recent mental health symposium, where I shared the impact of our work. Additionally, we now offer our services to Nga Maata Waka, whose clients have attended our mental health wananga.

We are also proud to announce a joint venture with the Graham Dingle Foundation, cocreating a PK Wananga, which will help extend the reach of our services.

One of the most exciting developments is our recent approval to pilot our program at Christchurch Men's Prison. This opportunity to support tane (men) in prison is a significant achievement and represents a step forward in delivering our services to an even wider community.

Despite these accomplishments, we continue to face the challenge of securing consistent funding. Financial stability has been a difficult and sometimes disheartening reality. However, when we do receive funding, we've proven time and time again that even on a shoestring budget, we can deliver our programs to a high standard and achieve significant success. Our resilience has been our strength, and through it all, we remain steadfast - never losing hope.

In addition to our mental health wananga and aftercare support, we have participated in promotional awareness campaigns, numerous talks, and fundraising efforts. We've also developed connections through Skillford & Co Ltd, which has enabled us to contribute to employment opportunities for graduates of our program.

Our hard work and dedication have not gone unnoticed. We've received several nominations for community recognition awards, including Westfield Local Hero, Kiwibank New Zealander of the Year, and Z Energy's Good in the Hood. These nominations are a testament to the impact we are having, even in the face of adversity.



I want to take this opportunity to express my gratitude to all of our

RTPOATA WHAKAHAERE KAUPAPA Operations Report

A very warm welcome to the new board member and heartfelt thanks to everyone who has been part of The Broken Movement Trust's journey.

As I enter my third year with the whānau at The Broken Movement Trust in the Operations role, I am excited to share the organisation's Operations Report for 2024.

Since joining in May 2022, my experience has been both rewarding and challenging, involving restructuring, program design, securing funding, and cultivating sustainable relationships that support our mission.

Last year, we proudly launched our inaugural care program, Wānanga Pukorero, aimed at helping men address trauma. Over the course of 2023 and into 2024, we successfully facilitated six wānanga, with attendance ranging from 8 to

25 men at each session. By utilizing Kaupapa Māori models and providing a supportive environment, we offered participants a valuable opportunity to engage with their healing journeys. The smaller wānanga proved particularly effective, fostering deeper connections, and allowing for a more intimate exploration of their experiences.

2024 Update: Throughout 2023 and 2024, we ran six wananga across Canterbury, with Living Springs emerging as a standout location. The positive impact of these gatherings has been reaffirmed by participant feedback, which highlights the critical need for such community-based healing spaces.

With the change in government in 2024, funding for trusts like ours has diminished. Nevertheless, Jacob and our dedicated team are actively pursuing new funding avenues, and we remain hopeful about continuing Wānanga Pukorero and expanding our programs into 2025.

As we navigate these challenging times, our commitment to spreading the importance of mental health remains steadfast. Through Skillford and Co Limited, our recruitment and labour hire company, we continually advocate for mental health awareness in alignment with the values of The Broken Movement Trust. By amplifying this vital message, we aim to create a broader impact in our community.

As we reflect on another challenging year, we are eager about the opportunities that lie ahead and remain dedicated to our mission of giving back to the community.

Description of Entity's Outcomes

Throughout the financial year, our main objective has been to accumulate funding and resources to effectively implement and deliver our programs and services to the communities within the Canterbury region.

Activities Undertaken

- Individual and community trauma recovery seminars
- Trauma Counselling for tane and wahine
- Individual mentoring services
- Aftercare services to measure long-term sustainable and personal success
- Whanau intervention support services to assist in the empowerment of breaking down stereotypes and stigmas relating to mental health, addiction and suicide.

Despite the financial challenges we faced during this year, our efforts were not in vain. We remained steadfast in our commitment to our mission and took concrete steps to lay the groundwork for the future. As we continue to accumulate funding and resources, we look forward to expanding our reach, opening our services to the public, and making a meaningful impact on the lives of those who need our support.

Description and Quantification of the Entity's Outputs

The Broken Movement Trust - Canterbury Area Mental Health Report (2023)

Outcome: The Broken Movement Trust's main objective in Canterbury is to improve the mental health and well-being of people, particularly those residing in the inner-city area of greater Canterbury.

Financially Quantifiable Output 1: The Broken Movement Trust secured funding of \$80,000 from Te Pūtahitanga-O-Te-Waipounamu contributing to salaries and Wānanga Pūkōrero program and service costs for seminars and wananga workshops over the financial year.

Financially Quantifiable Output 2: The Broken Movement Trust secured funding of \$9,200 in 2023/2024 year from the Department of Internal Affairs (Community Organisation Grants) which contributed towards operating expenses within the organisation and utilized to expand on our operational and administration costs.

Financially Quantifiable Output 3: In 2023/2024, The Broken Movement Trust successfully received another grant of \$10,000 through Rātā Foundation which contributed towards wānanga programme delivery and operational costs.

Description and Quantification of the Entity's Outputs

- Workshops and Support Sessions: The Trust organised and conducted several men's workshops, meetings, and support sessions throughout the year, serving over 90 participants. These interactive sessions focused on coping strategies, stress management, and building resilience.
- Awareness Campaigns: Several awareness campaigns were conducted both online and offline. These campaigns reached an estimated 100,000 individuals, fostering a more understanding and empathetic community towards mental health challenges.



Additional Output Measures

The increase in outcomes compared to the previous year can be attributed to a combination of factors. The Trust's proactive engagement with a range of community groups and funding stakeholders significantly enhanced our reach and resource investment. Additionally, increased public awareness and acceptance of mental health issues have contributed to more individuals seeking and benefiting from our programs and services.

It's important to note that the Trust faced challenges due to the changes of government funding priorities where mental health and social services were not afforded additional funding support and the organisation having to diversify and work on collaborating with other organisations to achieve the overall mission of the organisation.

Conclusion

In conclusion, the efforts of The Broken Movement Trust - Te Pou Awatea within the Canterbury area have yielded substantial progress in improving the mental health and well-being of the community, particularly within the inner-city region. Through strategic financial management, innovative programs, and effective partnerships, the Trust has made a positive impact on the lives of many individuals struggling with mental health challenges.


Rachael Ferguson
